## 5. 2018 RISE Sessions – Planning Committee Recommendations

Crystal provided details recommended by the RISE planning committee including the platform, content, preliminary dates and locations, etc. Building upon previous RISE Sessions, the theme for 2018 will be "Developing Attractive Communities". The format will be the same as previous years, including a buffet breakfast with a presentation followed by a panel discussion. The panel will showcase a variety of projects focused on successful community attraction.

Preliminary dates for RISE 2018 are: April 5<sup>th</sup> (Hayward), May 3<sup>rd</sup> (Washburn), May 31<sup>st</sup> (Phillips) – all sessions will begin at 8AM and convene around 10AM. Location details are still being finalized. More information through email will be distributed in late February/early March.

## 6. Wood Industry Collaborative - Update

The collaborative developed and finalized the strategic plan at the December 12<sup>th</sup> meeting outlining three main goals:

- 1) Maintain, grow, and replace the wood industry workforce
- 2) Expand the collaborative and develop legislative partnerships
- 3) Develop branding and marketing for the wood industry

A work plan was established for the upcoming meeting in February with clear, actionable steps to work toward goal achievement.

## 7. Inspire Northward - Update

Crystal noted that the Inspire Northward deployment plan/scope of work was included in the packet for participants to review. The scope of work for the project was submitted as a part of the application to fund the Inspire effort throughout the region to WEDC on November 10<sup>th</sup>. The plan outlines activities, deliverables, outcomes, and milestones. At this time, there has been no update on the application process other than the fact that it is currently in underwriting at WEDC.

#### 8. Around the Table

- Don Semler informed the group of the upcoming workforce job summit planning that is underway in Sawver County.
- ❖ Jim Miller inquired about the recent machine shutdown at Flambeau River Papers. MaryAnn Lippert assured that the Department of Administration is committed to helping and the DWD, etc. sent "SWOT" teams to help with immediate needs of those impacted by the shutdown.
- Seth Hudson noted that there will be an upcoming Housing Forum hosted by Momentum West on February 16th, 2018. For more information, contact Steve Jahn at <a href="mailto:steve@momentumwest.org">steve@momentumwest.org</a>.
- ❖ MaryAnn Lippert highlighted the upcoming Superior Days and Heart of the North Days. She also noted that there are five counties within the northwest region that have not applied for Broadband Expansion grants and that it is never too early to think about the next wave of funding − counties need to start putting together partnerships to move an application forward. There will likely be a mini-training session with staff at the Public Service Commission at Superior Days.
- ❖ Marie Steenlage provided an update on the FabLab grant program through WEDC and noted that eight schools expressed interest and six schools applied for funding from the region.
